SCHEDULE OF AMENDMENT
TO SUNNYBROOK II, A CONDOMINIUM

ADDITIONS INDICATED BY UNDERLINE
DELETIONS INDICATED BY STRIKE THROUGH
OMISSIONS INDICATED BY ELLIPSIS. . . .

Article 20 B., of the Declaration of Condominium of Sunnybrook II, A Condominium, is amended to read as follows:

20B. A Condominium Parcel may be leased for a period of not less than ninety (90) days. The Board shall require a Security Deposit of \$250.00 for each approved lease to be collected from the Unit Owner as security for the faithful performance of the lease terms as well as the governing documents of the Association by the Unit owner's tenants, guests or invitees. The Security Deposit shall be held by the Association in a non-interest bearing account in a Florida Banking institution for the benefit of the unit owner. The Security deposit will be refunded to the unit owner upon the expiration of the lease term after inspection by the Board of Directors or its manager or designee that no damages to the common elements were suffered. In the event the Board of Directors, its manager or designee, finds that damages to the Common Elements resulted from the tenants, their guests or invitees, a notice of intent to impose a claim of the Security Deposit will be mailed to the Unit Owner at the address maintained in the Association's records. Any repairs to the common elements resulting from the acts or omissions of the Unit Owners tenants, guests or invitees, are the responsibility of the Unit owner and shall become a lien on the unit collectable in the same manner as assessments for common expenses, together with interest at the highest allowable legal rate, attorney fees and costs.
