CERTIFICATE OF AMENDMENT TO DECLARATION OF CONDOMINIUM  
OF  
SUNNYBROOK VI, A CONDOMINIUM

We, Marie McDermott, as Vice President, and Irene Frankowski, as Secretary of SUNNYBROOK CONDOMINIUM ASSOCIATION, INC., do hereby certify that by vote of more than seventy-five percent (75%) of the condominium unit owners of SUNNYBROOK VI, A CONDOMINIUM, at the regular meeting of SUNNYBROOK CONDOMINIUM ASSOCIATION, INC., on May 30, 1989 at 6:30 p.m. held in accordance with the By-Laws of this Association, the following amendment was duly enacted:

Article 3, Section J, of the Declaration of Condominium, is amended to add the following:

J. It shall also be a common expense of the Association to provide significant facilities and services, or the availability of significant facilities and services, specifically designed to meet the physical or social needs of older persons as contemplated by the Federal Fair Housing Act.

Article 20, Section F, of the Declaration of Condominium is created to read:

F. Age Restriction. It is the intention of the Association to qualify for the exemption to the Fair Housing Act by providing housing for older persons as defined in Section 807(b)(2)C of the Federal Fair Housing Act (1988). Not less than eighty (80%) percent of the units shall have at least one (1) permanent occupant who is of age fifty-five (55) years or older, and all permanent occupants must be at least sixteen (16) years of age. The term "permanent occupants" shall include all persons occupying the unit, except temporary guests. "Temporary guests" shall be defined as those persons present in the unit for not more than thirty (30) days per temporary quest during any calendar year.

The Board of Directors shall promulgate, from time to time, such rules, regulations and procedures as are necessary to insure compliance with this restriction and consistent with an intent to comply with Section 807(b)(2)C of the Federal Fair Housing Act (1988).

This restriction shall not apply to any person residing in a unit in this Condominium on or before September 13, 1988.
